## Letter from the President

Rising costs and federal funding cuts threaten the very infrastructure that provides dental care to marginalized children who have nowhere else to turn.

Underserved children across the U.S. still wake up with toothaches that prevent them from concentrating in school or even prevent them from being able to go to school. They still suffer infections that could have been prevented. We all can agree that they still deserve the same quality of care as any other child. What has changed is that the safety net that was designed to protect them is fraying.

This is precisely the moment the AAPD Foundation was built for. Thanks to our donors' support, we stand ready to meet this crisis. Your generosity has allowed the Foundation to step up when our grantee clinics need us most. Now, we must do exactly that.

To our long-time supporters: Your sustained commitment has prepared us for this challenge, and we cannot thank you enough. To those considering joining our mission: There has never been a more critical time. When clinics close, children lose.

# Foundation allocates \$4 million in Bridge Grants for grantee clinics facing federal cuts

Millions of children are about to lose access to dental care. In response, the AAPD Foundation has committed \$4 million toward emergency grants for when anticipated cuts in federal funding take effect. These Bridge Grants – representing the largest single-year allocation in the Foundation's history – are intended to help mitigate some of the policy changes' devastating impact on vulnerable children.

"Unfortunately, these anticipated cuts are not a matter of if, but when," said AAPD Foundation President Dr. Mario Ramos. "And, with federal funding comprising on average two-thirds of nonprofit clinics' annual revenue, the consequences of these cuts are brutal: millions of vulnerable children will suffer."

Each year, roughly 20 million children access essential dental services through Medicaid reimbursements and local programs supported by federal grants. Once these policy shifts take effect, community clinics caring for the nation's most at-risk children will face impossible choices: curtailing operating hours, scaling back treatments, laying off essential staff, or shuttering their doors completely. Millions of children already living with tooth decay and oral pain will lose their only source of care.

"The AAPD Foundation always will stand up for kids," Dr. Ramos said. "That's why we have allocated nearly one quarter of our existing assets to meet this challenge."

The Foundation is currently developing application guidelines and review processes for qualifying clinics in order to respond swiftly once cuts materialize. Bridge Grants will be available by invitation only, with the Foundation aiming to distribute payments within 60 days following the application closing date.

"We know our funding cannot replace what will be lost, but we hope the speed of our fulfillment will serve as a bridge for our grantees – and the kids in their care – while they pursue funding from alternate sources," Dr. Ramos said. "There has never been a more important time to be a Healthy Smile Hero than now," he said.

## Beverly A. Largent Access to Care Innovator Award 2025

The winner of the 2025 Beverly A. Largent Access to Care Innovator Award sponsored by Elevate Oral Care is Dr. Maria Rita Z. Bernardo of FamilyCare Health Centers in West Virginia.

The Access to Care Innovator Award shines a light on someone making a big difference for little teeth. The award is named for an innovator of our own, the individual who took the first step in leading the Foundation into access to care: Dr. Beverly Largent. The Foundation is thrilled to recognize Dr. Bernardo as this year's honoree!

With more than 28 years of experience in general dentistry, Dr. Bernardo is highly revered by her community as a cornerstone of FamilyCare Health Centers and a tireless advocate for underserved kids across West Virginia.

Dr. Bernardo launched and continues to lead FamilyCare's Miles of Smiles Mobile Dental Unit, a school-based mobile program delivering preventive and restorative care to children in rural Appalachia—many of whom face significant barriers to care. She travels up to 120 miles round trip to ensure that even small numbers of students receive treatment, prioritizing equity and compassion in every community she serves.

Dr. Bernardo's dedication to service extends internationally. She has participated in dental missions to remote areas of the Philippines, providing extractions and education to communities with little or no access to dental care. This solidified her lifelong commitment to reaching the most vulnerable populations.



Eight-year-old Alex, a sweet and curious child with autism, needed specialized dental care under sedation. The journey to get it was not simple. With limited finances and a five-hour trip to the clinic, Alex's family faced an overwhelming challenge.

Thanks to the dedication of the entire team at St. Bernard Dental Center, they were able to make it possible. Through virtual consultations and coordination with Alex's primary care doctor, they gathered all the necessary documentation. On the day of surgery, the staff helped arrange transportation and housing, ensuring the family could focus on what mattered most -Alex's care.

## **University of Minnesota Cleft and Craniofacial Clinic**

Minneapolis, MN

Ethan is a bright young teen from rural Minnesota who faced an uphill battle to receive basic dental care. Ethan had dental anxiety, and access to dentists who are comfortable treating children with cleft and craniofacial differences is nearly nonexistent in his area. When he came to U of MN Craniofacial Clinic, the exam revealed caries on every single tooth - some beyond repair - despite his mother's tireless efforts to find care.

Ethan's mother tried multiple clinics, but the complexity of his condition meant he was repeatedly referred elsewhere. Even though they had state insurance, very few providers accepted it, and even fewer could treat someone with his specialized needs. On top of that, Ethan had other medical conditions that further strained the family's limited resources.

Thanks to the Access to Care Grant, the U of MN Craniofacial Clinic team stepped in where others could not. Even though their clinic was out-of-network for Ethan's insurance, the funding from the AAPD Foundation allowed them to provide Ethan the comprehensive dental care he urgently needed and deserved.

## Three Year Access to Care Grant recipients

Improving dental health care access requires innovation and time for solutions to work. Recognizing this, the AAPD Foundation invites qualified One Year Access to Care Grantees to apply for \$225,000, three-year grants, amplifying their resources and reach. Three Year Access to Care Grants support continuous, comprehensive oral health care for children through ongoing dentist-patient relationships that are accessible, coordinated, and family-centered.





#### KinderSmile Foundation

KinderSmile Foundation's Link to a Dental Home · Bloomfield, New Jersey

KinderSmile Foundation was founded in the community and for the community to fill a gap in available resources for children in New Jersey. KinderSmile's clinics are free of typical barriers to care that underserved communities face - they accept all patients regardless of insurance status and behavioral management needs, offer ease of transportation, offer flexible hours for working parents, and care for very young children.

KinderSmile turns no patient away and their focus on offering compassionate, culturally sensitive care builds healthy lifelong oral health habits and confidence. The Access to Care Grant is funding clinical supplies and salaries of dental care providers at the clinic and helping them to deliver essential, barrier-free dental care to over 6,000 underserved children per year.

#### **Caridad Center**

Health Equity for All · Boynton Beach, FL

Caridad Center is a dental care safety net to marginalized community members and offers a full range of free dental services, including oral care and prevention education, cleanings, extractions, emergency treatments and surgeries. The Access to Care Grant is expanding Caridad's resources to include an additional pediatric dentist on staff and additional hours of operation for pediatric appointments on Saturdays so children do not miss school. By increasing preventive care, improving treatment completion rates, and connecting families to comprehensive health services, Caridad is ensuring high quality dental care for historically marginalized children.



#### **CommuniCare Health Centers**

CommuniCare Health Centers Pediatric Dentistry Program San Antonio, TX



The Access to Care Grant money covers a portion of the salary of CommuniCare's pediatric dental provider, who see patients at both the East and West campuses of the clinic and provides pediatric patients with oral exams, cleanings, sealants, fillings, extractions, stainless steel crowns, pulpotomies, space maintainers, nitrous oxide, and levels 1 and 2 sedations. This funding will enhance CommuniCare's ability to continue providing specialty care to San Antonio's most vulnerable communities.

### Lancaster Cleft Palate Clinic

Dental Home for Children with Special Health Care Needs · Lancaster, PA

The Lancaster Cleft Palate Clinic (LCPC) uses support from the AAPD Foundation to improve access to high quality pediatric dental care for children with special health care needs in Central Pennsylvania, a dental health provider shortage area.

The Grant is funding additional clinical staff members, pediatric dental equipment, and an additional pediatric dentist to give the clinic increased capacity to address its high demand for services. LCPC's interdisciplinary craniofacial team treats children with cleft and craniofacial differences. Their primary mission is to care for children with a high burden of dental needs. Patients are often experiencing the effects of poverty, extensive tooth decay, and/or behavioral challenges such as autism.

Support from Access to Care Grants has helped the Clinic grow their pediatric dental program by 39% over the last five years.

## Oak Park River Forest Infant Welfare Society

Dental Home for Low-Income Chicago-Area Children · Oak Park, IL

Oak Park River Forest Infant Welfare Society (OPRF IWS) Children's Clinic provides affordable dental care to low-income children in western Cook County and is one of the only safety nets in the area for families with public insurance or no insurance. OPRF IWS provides full preventive and restorative pediatric care, including oral exams, oral health education, cleanings, fluoride treatments, sealants, extractions, cavity repair, and space maintainers. The Access to Care Grant is supporting the salaries of the clinic's pediatric dentists. The funds have been instrumental in stabilizing the clinic's dental team as it works to expand services to children with special health care needs, children who have complex or extensive oral health problems, and children with behavioral health challenges.

## University of Maryland, Baltimore

Oral Health for Underserved Uninsured Children (OH-UUC) Baltimore. MD

OH-UUC addresses the oral health needs for the Baltimore community's undocumented children, children from limited income, and uninsured families, providing comprehensive care including chronic disease management, oral health education, preventive services, restorative care, and advanced behavior guidance techniques including nitrous oxide and sedation.

A high percentage of undocumented patients come from Spanish-speaking families, and a bilingual staff member contacts those families to set up appointments and works with providers for needed patient communication.

The Access to Care Grant is helping OH-UUC expand to include advanced services such as permanent teeth endodontics, minor surgical procedures (performed by oral surgery), early orthodontic interventions, and treatment in the operating room setting.

## **Community Volunteers in Medicine**

Comprehensive Dental Care for Low-Income, Uninsured Children · West Chester, PA

Community Volunteers in Medicine (CVIM) provides preventive, restorative and emergency services, along with oral health education and dental hygiene supplies for low-income, uninsured members of their community. Many of these families speak primarily Spanish. The Access to Care Grant is funding additional hours for a bilingual pediatric dentist who is certified to use nitrous oxide. This is important for young children with significant issues who may have never seen a dentist and react with strong anxiety. The grant is also funding a dental assistant who works chairside with the dentist. coordinates care with families, and helps facilitate CVIM's partnership with local school districts. Over the past six months, grant funding has enabled CVIM to provide comprehensive care for more than 400 uninsured, low-income children through school and Head Start partnerships.

#### Salt Lake Donated Dental Services

Community Pediatric Sedation Project · Salt Lake City, UT

Salt Lake Donated Dental Services (SLDDS) works diligently to increase equity by advancing access to essential and critical healthcare in their community despite the social determinants of health. Children often present at the clinic in need of extensive dental care. Oftentimes the only way SLDDS can provide the dental care they need is with general anesthesia services. The Access to Care Grant is funding safe, affordable sedation services and comprehensive dental treatment for up to 240 children. SLDDS's pediatric dentist and anesthesiologist work to complete all necessary procedures and treatment to restore the child's oral health in a single appointment, restoring their oral health and reducing financial barriers for families. #### PATIENT STORY

When Heather and her daughter Grace moved to Utah, they were unable to qualify for Medicaid and unable to afford private insurance. Without coverage, they lost access to every medical and dental service they once relied on. Heather faced the painful reality of not being able to get her daughter the care she needed.

Grace's teeth were broken and damaged, and she endured cruel bullying at school because of her appearance. She stopped smiling and laughing, afraid of being ridiculed or hurt again. It was devastating for Heather to watch her daughter's confidence disappear, knowing she couldn't afford the costly dental treatment.

Their situation changed when a counselor at the junior high referred the family to Salt Lake Donated Dental Services. The clinic's director welcomed them with compassion and created an affordable, step-by-step treatment plan. Under the care of the skilled and caring dentists at the clinic, Grace finally received the dental procedures she had long needed.

Today, Grace's radiant smile has returned, and her confidence shines brighter than ever. Heather and Grace are deeply grateful to the doctors, staff, and generous donors whose kindness and support made this transformation possible!



## **Variety Care & Variety Care Foundation**

Variety Care Anesthesia Initiative for Uninsured Children · Oklahoma City, OK

Variety Care is the only Central Oklahoma organization offering uninsured people comprehensive oral health care. Most of their patients struggle with poverty and the toll a lack of financial resources has on their health. Often children will need treatment under anesthesia, but hospital operating room time is minimally available, even for patients with insurance or who can self-pay. Barriers are even more significant for low-income, uninsured patients. The Access to Care Grant is funding sedation and dentist costs so Variety Care can provide sedation in a clinic setting as appropriate for individual patients.

## AAPD/AAPD Foundation Leadership Institute renamed the Dr. John S. Rutkauskas Leadership Institute

In honor of retiring CEO Dr. John S. Rutkauskas's 27 years of service to the American Academy of Pediatric Dentistry and the American Academy of Pediatric Dentistry Foundation, the Boards of both organizations unanimously voted to rename the AAPD/AAPD Foundation Leadership Institute the Dr. John S. Rutkauskas Leadership Institute. The renaming of the program will be effective with Cohort VIII, which will begin in December 2026.

"I cannot think of a more appropriate honor for John," said AAPD Foundation President Dr. Mario Ramos. "He was instrumental in the program's development as a means for identifying, investing in, and developing future pediatric dental leaders."

The brainchild of AAPD and AAPD Foundation Past Presidents Drs. Joel Berg, David K. Curtis and Jerome B. Miller, more than 200 pediatric dentists and dental leaders over the last 20-plus years have received elite leadership training at the Kellogg School of Management at Northwestern University.

"In my 14 years on staff, I've had the privilege of working with John and the Kellogg team in program structure and course selection," said AAPD Senior Vice President, Foundation and Integrated Marketing, Paul Amundsen. "He's meant so much to Leadership Institute, every step of the way."

More than 80 applicants have vied for 30 spots in each of the last three Cohorts, and recruitment now reaches deeper into the Academy membership, engaging and training the leaders of today – and tomorrow. "David, Jerry and Joel envisioned a program that would 'build our bench,' and John's steady hand has allowed Leadership Institute to do just that," Dr. Ramos said.


